Any youth who does not comply with these rules and standards, or whose conduct or attitude undermines the positive environment and objectives of an event, or who has made any false, misleading or incomplete statements in this application or the Medical Form is subject to being sent home at his/her parents' expense.

AGREEMENT AND RELEASES

I/we understand that if he/she violates Youth Group rules or standards or endangers the safety or well-being of the other participants or staff or otherwise fails to comply with the foregoing requirement to which he/she has agreed, that he/she can be sent home at the director’s request, which, I/we agree will be at my/our expense. I/we understand there is no reimbursement of fees after 26 days before an event begins. Before that time, a processing fee of \$25.00 will be withheld from the refund unless the space is filled. I/we believe my/our son/daughter is in good health and can participate in strenuous activities and the usual routine associated with the event. I/we verify and concur that the information supplied in this is true and compete.
